1. Impact of the CoVID-19 pandemic on the business

The Company is engaged into Hotel Business . The Company had accelerated the efforts for completion of renovation process and the re-opening of the Hotel was expected in the month of April 2020..

However, due to Covid-19, there has been a continuous lockdown in the state of Tamil Nadu (*specifically Chennai where the Hotel is located*) which has impacted the schedule of re-opening of the Hotel.

2. Ability to maintain operations including the factories/units/office spaces functioning and closed down
